EQUINE FACILITIES RULES and POLICIES

<u>Please read carefully</u> as any breach of MRAS rules or policies may result in revocation of ALL MRAS access and/or privileges, without refund

Equine Facilities collectively refer to all the MRAS grounds including but not limited to: indoor arena, sand ring, rodeo ring and racetrack

ACCESS AND FACILITY USE

- a) Riding Member and/or pass holder must be in good standing with MRAS.
 (Note: Riding Members must purchase an MRAS annual general membership prior to purchase of their Riding Membership)
- b) Equine Facilities hours of operation: 7:00 am to 10:00 pm (or as otherwise posted)
- c) Fees and executed documents must be submitted prior to receipt of FOB (indoor arena access) and code (combination) for outdoor facility access.
 - FOBs are Non-transferrable and combination to be kept Confidential
- d) Only Riding Members, pass holders, user groups or pre-booked rental users are allowed to ride on MRAS grounds or Equine Facilities.
- e) Riding access available in one hour time slots (maximum of 2 consecutive times) and must be booked in advance of entering the facilities NO exceptions
 - o 6 riders max.
- f) Riding Members are responsible to check the MRAS calendar and/or booking system before coming to use the facility.
- g) Turn off lights when done unless otherwise instructed.
- h) NO LESSONS are to be conducted at any of the MRAS facilities without being booked as a private function.

CONDUCT

- a) Riding Members and pass holders will conduct themselves in a cooperative manner to allow for the multidiscipline activities at all MRAS Equine Facilities while being respectful of other riders and everyone's safety.
- b) Clean up after yourself and your horse. Pick up manure from all riding surfaces as well as parking lots and place in proper receptacles.
 - Summer: deposit manure in outside receptacle
 - Winter: wheelbarrows used for manure collection to be left in arena corners
- c) **DO NOT** clean out trailers anywhere on MRAS grounds.
- d) Parking available north of the Indoor Arena or Infield area **ONLY**. **DO NOT** park horse trailers, load and unload, on the main access road into the facility.
- e) NO riding in the campgrounds or market areas if you have questions in this regard, please ask.
- f) NO SMOKING in or near any MRAS building.
- g) NO DOGS or PETS allowed in riding areas.
- h) NO ALCOHOL is permitted on the grounds unless proper approval or permits are obtained.
- i) Illegal drugs and activities are not permitted.

- j) Equine businesses are not permitted on MRAS grounds unless they are part of a commercial booking/rental or in the event of emergency or if approved by the office.
- k) No feeding horse in Equine Facilities
- I) If there is no one else in the indoor arena, turn out the lights (unless instructed otherwise) and ensure the doors are closed and secure as you leave.

SAFETY

- a) Anyone under 18 years of age must be accompanied by a parent or guardian at all times.
- b) MRAS requires anyone under the age of 18 to wear a certified helmet when riding on MRAS property.
- c) Everyone using jumps on MRAS property is required to wear a certified helmet.
- d) Report any damages or safety risks by email to MRAS.equine@gmail.com or to the office at office@mras-track.com
- e) Always be aware of other riders to avoid unexpected interactions.
- f) Unique activities, such as, but not limited to, Mounted Shooting, Archery on Horseback, use of Frisbees/beach balls are all PROHIBITED during public riding times. Contact the office for private rentals.
- g) Riders must be in control at all times.
- h) Lunging is permitted under the following circumstances:
 - o If Equine Facility is not already in use, and
 - o You ask permission from riders already in the Equine Facility
 - When others enter, please limit time to 10 minutes.
 - NO free lunging or turning out allowed at any time.
- i) If you set up equipment, please ensure that all equipment is returned to its original location.
- j) DO NOT tie horses to panels.
- k) Indoor Arena discourage pawing, tie horses where mats are available.
- I) Indoor Arena NO SLIDING stops.
- m) Riding members may only bring two (2) horses maximum per visit. If possible, the non-ridden horse should be tied to your trailer.
